NOTICE OF HEARING
September 9, 2019

NOTICE IS HEREBY GIVEN to all interested persons within Burnet County, Texas:

That the Board of Directors of the Central Texas Groundwater Conservation District (CTGCD) will hold a public hearing, accept public comment, and may take action on the adoption of proposed amendments to CTGCD's Rules regulating groundwater in Burnet County, Texas and amendments to the CTGCD Bylaws.

The proposed rules amendments may adopt changes as follows: Rule 1.01 definition of Contiguous Controlled Acre; Rule 3.62 General Manager's authority to act on Small Well applications after notice and opportunity for hearing; Rule 3.64 cross reference correction to required production reports for new wells; Rule 3.67 eligibility requirements for Permit by Rule; Rule 5.02 clarification regarding establishment of a special production regulation or permit; Rule 6.04 well completion standards for certain wells; Rule 11.01 meters required for certain new wells in an aggregate well system; Appendix A minimum tract size requirements in connection with well spacing requirements; and, Appendix B hydrological investigation and reporting requirements relating to wells authorized to operate pursuant to Permit by Rule.

The proposed Bylaw amendments may adopt changes to *Bylaw 3.1 Regular and Special Meetings of the Board* and *Bylaw 3.2 Work Sessions* relating to when public comment is allowed at meetings and work sessions of the Board of Directors; and, *Bylaw 6.2 Minutes and Records of the District* and the addition of *Appendix A - Central Texas Groundwater Conservation District, Records Management Policy* relating to the preservation, storage, destruction, or other disposition of the District's records under Title 6, Subtitle C Texas Local Government Code including, as the new *Appendix A, Records Management Policy*.


Changes may be made to the proposed amendments to the CTGCD's Rules and Bylaws based upon comments received or made at the hearing, and the amendments may be adopted with or without such changes without further notice or hearing.

This rulemaking hearing will be held on Monday, September 9, 2019, beginning at 9:00 a.m. at the District Offices, located at 225 S. Pierce, Burnet, Texas.

Any person who desires to appear at the hearing and present comment or other information on the proposed amendments to the CTGCD's Rules and Bylaws may do so in person, by counsel, or both. Comments may be presented verbally or in written form. Limits may be placed on the amount of time that each person is allowed to present verbal comments. The hearing posted in this notice may be recessed from day to day or continued where appropriate.
