

**NOTICE OF PERMIT HEARING OF THE CENTRAL TEXAS

Notice is hereby given that the Board of Directors of the Central Texas Groundwater Conservation District ("District") will hold a Permit Hearing on Friday, April 15, 2011 at 9:00 a.m. in the District office located at 225 S. Pierce Street, Suite 104, Burnet, Texas.

Notice is hereby given that an application for a new well has been determined to be administratively complete. The Permit Application and this notice are in accordance with District Rule 3.62 Operating Permit for New Wells (c) Smaller Wells. Operating Permits issued pursuant to § 3.62 (c) are issued with authorization to drill, complete, and operate a new, non-exempt well proposed to produce 10 acre-feet of water per year or less, or that will have a maximum capacity of 50 gallons per minute or less, may be issued as a single permit, in the form of an Operating Permit.


Protest Application
