NOTICE OF HEARING ON APPLICATION FOR PERMIT AMENDMENT

NOTICE: the General Manager of the District has determined the following application(s) are administratively complete, conducted a technical review of applications, and prepared recommendations for consideration by the Board of Directors ("Board"): A preliminary hearing on the proposed permits will be held on Wednesday October 25, 2023 at 9:00 a.m. at the District's office at 225 South Pierce Street, Suite 104, Burnet, TX 78611, in accordance with the District's rules. Each proposed permit application and its underlying application is available for inspection at the District's office.

The Board of Directors may deny or grant in full or in part a permit application, and issue a permit in any amount less than, or equal to the amount claimed in the application, based upon the evidence received at the hearing and notwithstanding the General Manager's recommendation.

In order to request a contested case hearing on an application, the applicant or an affected person, in accordance with District Rules must provide the District with a written request for a contested case hearing seven (7) days before the date of the intended action stated in this notice and appear before the Board at the hearing and oppose the application. Written requests received after this deadline will not be considered timely filed, and will not be further processed by the District.


Recommendation by General Manager:
